Sub: Clarification regarding Centralized Online Admissions for UG Courses for the Session 2023-24.

In continuation of DHE-010019/6/2020-Coordination-DHE-Part (1) dated 12.06.2023, I have been directed to issue the following instructions regarding Online Admissions 2023-24:

1. The point/clause number 4 mentioned in letter No. DHE-010019/6/2020-Coordination-DHE-Part(1) dated 12.06.2023 is substituted as under:-

The Colleges (wherever NEP is applicable) having Computer Science, Geography, Mathematics, Statistics as sanctioned subjects either in B.A or B.Sc (Non-Medical), the permission is hereby granted to allocate these subjects as Minor subject towards Bachelor of Physical Sciences or Bachelor of Arts respectively in order to effectively implement National Education Policy. As an illustration, if Geography is a sanctioned subject in B.A, the same can be allocated as Minor subject in Bachelor of Physical Sciences & Vice-versa.

- 2. Merit List shall be prepared on the basis of major & minor only. During Open Counselling, Principals shall ensure to fill the leftover seats as per merit.
- 3. The Major and Minor subjects offered to the students by the Colleges must have prior approval from Directorate of Higher Education, Haryana/Affiliating University.
- Minor subject can be offered from the same discipline and should be different from those three subjects which are opted as Major Subjects in that discipline.
- 5. In case of Physical Science and Life Science disciplines, when a minor subject cannot be offered by the College, the Minor Subject can be offered from either of the two disciplines.
- 6. Since the colleges have been sanctioned some courses as honours courses in previous years, the admissions in such courses under National Education Policy for this year shall be in Honours Programmes only instead of Single Major. For the next years, the colleges may send their proposals to start new courses in-line with NEP.
- 7. All the subjects in UG Multidisciplinary programmes are Elective subjects in NEP-2020 Frame work. Therefore, there will not be any difference between Compulsory or Elective hereafter. As an illustration, if English (Elective) and English (compulsory) are sanctioned subjects, the same may be treated as English only.
- 8. The fee/funds pertaining to allotment of Multidisciplinary Courses (MDC), Skill Enhancement Courses (SEC), Value Added Courses (VAC), Ability Enhancement

to

Courses (AEC) etc. shall be collected at college level from the students as per State Government/Affiliating University Norms.

- 9. Refund of excess amount / Short Payment (if any), shall be handled at college level as per State Government/Affiliating University Norms on account of first time implementation of NEP structure.
- 10. All the admissions shall be provisional only. The colleges shall abide by all instructions issued by State Government and affiliating university before submission of Registration Return. Discrepancy, if any, shall be resolved at Principal/college level.
